## ENTER TO WIN 1 OF 2 TRIPS TO COSTA RICA CONTEST RULES

THE ENTER TO WIN 1 OF 2 TRIPS TO COSTA RICA CONTEST (THE "CONTEST") WILL BE CONDUCTED IN CANADA ONLY (EXCLUDING QUÉBEC) AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THEIR PROVINCE OR TERRITORY OF RESIDENCE OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

# 1. ELIGIBILITY.

- 1.1 To be eligible for this Contest, an individual must:
  - (a) be a legal resident of Canada (excluding the province of Québec);
  - (b) be of the age of majority in their province or territory of residence or older at the time of entry; and
  - (c) be legally able to travel to Costa Rica and have any and all necessary documentation that may be required for presentation to Canadian and/or International customs and airport personnel.
- 1.2 The following people are not eligible to enter the Contest:
  - (a) Employees of Corus Television Limited Partnership by its general partner Corus Television G.P. Inc. its parent, affiliates, subsidiaries, related companies, successors and assigns (collectively "Corus");
  - (b) Employees of the Costa Rican Tourism Board (ICT) its affiliates, subsidiaries, related companies, successors and assigns (collectively, "TBCR", together with Corus, the "Sponsors");
  - (c) Employees of VMC Media its affiliates, subsidiaries, related companies, successors and assigns, advertising and promotional agencies;
  - (d) Any person who has been confirmed as a winner of two (2) Corus administered contests within six (6) months preceding the Contest start date indicated below; and
  - (e) The household members of any of the parties listed in Section (a) to (d) above.
- 1.3 The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsors for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply information that does not meet these requirements.

2. CONTEST PERIOD. The Contest begins at 12:00a.m. Eastern Time ("ET") on September 14, 2022 and ends at 11:59p.m. ET on September 25, 2022 (the "Contest Period") after which time the Contest will be closed and no further entries shall be accepted.

#### 3. HOW TO ENTER.

- 3.1 There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.

- 3.2 Limit of one (1) entry per person during the Contest Period. In the case of multiple entries, only the first eligible entry will be considered.
- 3.3 All entries become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- 3.4 Entries received online shall be deemed to be submitted by the authorized account holder of the email address associated with the entry. For the purpose of the Contest Rules, "authorized account holder" of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. # 4. PRIZES.

- 4.1 **Prizes.** There are two (2) prizes (the "**Prizes**", each a "**Prize**") available to be won by the Prize winners (the "**Winners**", each a "**Winner**") consisting of: a trip for two (2) to San Jose, Costa Rica or Guanacaste, Cota Rica (each a "**Destination**") which shall include:
  - (a) Round-trip economy airfare for the Winners and one (1) guest per Winner (the "Guests", each a "Guest") leaving together from the same gateway, on the same itinerary, from a major Canadian airport located near the Winner's home, as determined by the Sponsors in their sole discretion, to the Destination;
  - (b) Ground transportation for the Winners and Guests between the airport and hotel in the Destination;
  - (c) Four (4) nights hotel accommodation in the Destination to be selected by the Sponsors in their sole discretion for the Winners and Guests based on double occupancy unless otherwise indicated;
  - (d) One (1) round of admission for each Winner and their Guest to a National Park in Costa Rica; and
  - (e) Breakfast for each Winner and their Guest for each day during the Prize.

- 4.2 Each Prize has an approximate value of four thousand Canadian dollars (CDN \$4,000). Actual value of Prize will depend on departure city.
- 4.3 Winners are not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- 4.4 The Sponsors and/or the Sponsors' representatives will contact the Winners to coordinate the provision of the Prizes within thirty (30) days once such Winners have been successfully contacted and notified of their Prize and fulfilled the requirements set out herein.

#### 5. PRIZE CONDITIONS.

- 5.1 All bookings and/or reservations are subject to availability at time of booking. Blackout dates apply, including but not limited to: (i) December 15, 2022 to March 31, 2023; (ii) April 2, 2023 to April 8, 2023; and (iii) July 1, 2023 to August 31, 2023. Winners and their Guests must be available to travel together from November 1, 2022 through October 31, 2023. Should Winners and/or Guests be unable to travel together on the dates and times designated by the Sponsors, the Prize will be forfeited and awarded to an alternate winner.

- 5.3 Guests must: (i) be of the age of eighteen (18) or older in their province or territory of residence; (ii) be legally able to travel to Costa Rica and have any and all necessary documentation as may be required for presentation to Canadian and/or International customs and airport personnel; and (iii) comply with the Contest Rules and sign and return the Release (described below).
- 5.4 In the event that, due to the COVID-19 pandemic, or such other pandemic that causes such government regulations to be put in place during the time period in which the Prize must be redeemed, the Sponsors will make best efforts to coordinate the Prize once such regulations have been lifted. If the Sponsors are unable to reschedule or provide any portion of the Prize because of such government regulations in place or circumstances beyond their control, then the Prize shall be deemed fulfilled and will not be substituted, except in the sole discretion of the Sponsors.
- 5.5 Prizes must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. #### 6. WINNER SELECTION.

6.1 Two (2) Winners shall be selected as follows:

- (a) On or about September 26, 2022 in Toronto, Ontario, two (2) entrants will be selected by a random draw from all eligible entries received during the Contest Period. Each entrant shall be eligible to win only one (1) Prize. The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsors. Before being declared a Winner, each selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail, to comply with the Contest Rules and to sign and return the Release (described below).

Upon notification, the selected entrant must respond by telephone or e-mail (as specified in the notification) to the contact number or e-mail address provided no later than the indicated deadline set out in the Contest Rules and/or the notification. If the selected entrant does not respond accordingly, they will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.
- (c) If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.
- 7. RELEASE.
