### JETAWAY WITH STACEY BROTZEL CONTEST RULES

THE JETAWAY WITH STACEY BROTZEL CONTEST (THE "CONTEST") WILL BE CONDUCTED IN THE PROVINCE OF ALBERTA ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. ENTRANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF ALBERTA OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

## 1. ELIGIBILITY.

- 1.1 To be eligible for this Contest, an individual must:
  - (a) be a legal resident of the province of Alberta;
  - (b) be of the age of majority in the province of Alberta or older at time of entry;
  - (c) be legally able to travel to South Africa between January 21, 2025 and January 30, 2025 and have any and all necessary documentation that may be required for presentation to Canadian and/or International customs and airport personnel.
- 1.2 The following people are not eligible to enter the Contest:
  - (a) Employees of Corus Radio Inc., operating as CHED-AM (the "**Station**") and its parent, affiliates, subsidiaries, related companies, successors and assigns (together with the Station, "**Corus**");
  - (b) Employees of Newwest Travel Ltd, its affiliates, subsidiaries, related companies, successors and assigns (collectively, "New West Travel", together with Corus, the "Sponsors");
  - (c) Any person who has been confirmed as a winner of two (2) Corus administered contests within six (6) months preceding the Contest start date indicated below where the prize was valued at over one thousand Canadian dollars (CDN\$1,000); and
  - (d) The household members of any of the parties listed in Section (a) to (c) above.
- 1.3 The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsors for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply information that does not meet these requirements.
- 2. CONTEST PERIOD. The Contest begins at 6:00 am Mountain Time ("MT") on September 3, 2024 and ends at 7:00 pm MT on October 3, 2024 (the "Contest Period") after which time the Contest will be closed and no further entries shall be accepted.

## 3. HOW TO ENTER.

- 3.1 There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.
- 3.2 Limit of one (1) entry per person per day. In the case of multiple entries, only the first eligible entry will be considered.
- 3.3 All entries become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.

## 4. PRIZE.

- 4.1 There is one (1) prize (the "**Prize**") available to be won by the Prize winner (the "**Winner**") consisting of: a trip for two (2) to Cape Town, South Africa (the "**Destination**") which shall include:
  - (a) Round-trip economy airfare for the Winner and their guest (the "Guest") leaving together from the same gateway, on the same itinerary, from a major Canadian airport located near the Winner's home, as determined by the Sponsors in their sole discretion, to the Destination;
  - (b) Ten (10) nights hotel accommodation at a hotel or such other venue (the "**Hotel**") to be selected by the Sponsors in their sole discretion for the Winner and Guest based on double occupancy unless otherwise indicated;
  - (c) Ground transportation for the Winner and Guest between the airport and Hotel;
  - (d) Ground transportation for the Winner and Guest between the Hotel and each Safari (as defined below);
  - (e) Nine (9) breakfasts, one (1) lunch and four (4) dinners for the Winner and Guest during the trip; and
  - (f) Two (2) safari game drives for the Winner and Guest at Kruger National Park, which includes one (1) guide and all entrance fees (each a "**Safari**").
- 4.2 The Grand Prize has an approximate value of seventeen thousand Canadian dollars (CDN\$17,000).
- 4.3 Winner is not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- 4.4 The Sponsors and/or the Sponsors' representatives will contact the Winner to coordinate the provision of the Prize within two (2) days once such Winner has been successfully contacted and notified of their Prize and fulfilled the requirements set out herein.

# 5. PRIZE CONDITIONS.

- 5.1 All bookings and/or reservations are subject to availability at time of booking. Winner and their Guest must be available to travel from February 3, 2025 through February 12, 2025. Should Winner or Guest be unable to travel on the dates and times designated by the Sponsors, the Prize will be forfeited and awarded to an alternate winner.
- 5.2 Winner and Guest will be responsible for any other expense not explicitly included in the Prize including but not limited to: transportation to and from originating airport, travel and medical insurance, travel documentation, airport improvement fees, bag check fees, taxes, gratuities, telephone calls, and in-room charges. - 5.3 In the case of event tickets, gift cards or gift certificates, the terms by which the event tickets, gift cards or gift certificates may be redeemed are governed by the applicable retailer or service provider. Corus is not responsible for administering or ensuring compliance with the terms and conditions of the event tickets, gift cards or gift certificates.
- 5.4 Guest must: (i) be of the age of majority or older in their province or territory of residence; (ii) be legally able to travel to South Africa and have any and all necessary documentation as may be required for presentation to Canadian and/or International customs and airport personnel; and (iii) comply with the Contest Rules and sign and return the Release (described below).
- 5.5 Prize must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused, unclaimed or declined portion of the Prize will be forfeited, have no cash value and the Sponsors shall have no obligation to provide either an alternative or value-in-kind. The Sponsors reserve the right, in their sole discretion, to substitute a prize of equal or greater value if a Prize (or any portion thereof) cannot be awarded for any reason.
- 5.6 Shipped Prizes shall not be insured and the Sponsors shall not assume any liability for lost, damaged or misdirected Prizes.

# 6. SELECTION.

- 6.1 One (1) Winner shall be selected as follows:
  - (a) On or about October 4, 2025 in Edmonton, Alberta, One (1) entrant will be selected by a random draw from all eligible entries received during the Contest Period. Each entrant shall be eligible to win only one (1) Prize. The odds of being selected as a potential winner are dependent upon the number of eligible entries received by Corus. Before being declared a Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail to comply with the Contest Rules and to sign and return the Release (described below).
  - (b) THE SELECTED ENTRANT WILL BE NOTIFIED BY TELEPHONE AND/OR E-MAIL NO LATER THAN OCTOBER 4, 2024 AT 8:00AM MT AND MUST RESPOND WITHIN TWO (2) BUSINESS DAYS OF NOTIFICATION. Upon notification, the selected entrant must respond by telephone or e-mail (as specified in the notification) to the contact number or e-mail address provided no later than the indicated deadline set out

in the Contest Rules and/or the notification. If the selected entrant does not respond accordingly, they will be disqualified and will not receive \*a/the\* Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.

- (c) If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.
- 7. RELEASE. The Sponsors are not responsible for any incorrect or inaccurate information, whether caused by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the administration of the Contest. The Sponsors assume no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including reasons beyond the control of the Sponsors, such as tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest.

bound by the Contest Rules, which will be posted at the contest microsite and made available throughout the Contest Period. Each entrant further agrees to be bound by the decisions of the Sponsors, which shall be final and binding in all respects. - 11.2 Each Winner further consents that: (a) any personal information they have provided in connection with this Contest may be shared with New West Travel for the purpose of facilitating the delivery or fulfillment of a Prize; and (b) Corus may broadcast, publish, disseminate and otherwise use a Winner's name, city/town/village and province/territory of residence, image and/or voice in connection with any promotion and/or publicity purposes without further compensation to Winner.
- 11.3 No communication unrelated to the Contest, commercial or otherwise, will be sent to the entrant unless the entrant otherwise expressly agrees to receive further communications from Sponsors.

All issues and questions concerning the construction, validity, interpretation and enforceability of the Contest Rules or the rights and obligations as between the entrant and the Sponsors in connection with the Contest shall be governed by and construed in accordance with the laws of the province of Ontario without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws.
