On Friday, March 27, 2026, at approximately 1402 hours, I, Deputy T. Levenar, responded to 281 S Beach Rd in reference to a DUI Investigation.

Units responded to the above location in reference to a two-vehicle traffic crash.

A white Ford, F-150 bearing FL Tag# [REDACTED] (V2) with an attached trailer was traveling north bound on S Beach Rd. A black Land Rover bearing FL Tag# GYKL56 (1) was traveling directly behind V2. As V2 slowed down to make a right turn into a driveway, V1 proceeded to go into oncoming traffic, traveling over the double solid line. As V1 maneuvered around V2, it struck V2. V1 struck V2 with the front right bumper/fender to the rear left fender of the attached trailer. Due to the impact, V1 lost control and flipped on the driver's side.

Driver of V1, identified by FL driver's license as Eldrick T. Woods advised Deputy G. Brenovil that he looked down at his cell phone and did not realize that V2 had slowed down. Woods did not report any injuries sustained from the collision.

Driver of V2, identified by FL driver's license as Jeremy T. Bullard, also did not report any injuries sustained from the collision. Martin County Fire Rescue responded to the scene and medically assessed both drivers. Both drivers refused to be transported to the hospital.

Upon arrival, I made contact with Deputy Brenovil, he advised me on the above details. Deputy Brenovil advised while speaking to Woods, he observed several signs of impairment and requested I conduct a DUI Investigation to ensure Woods was able to operate the motor vehicle in a safe manner at the time of the collision. Deputy Brenovil advised he had conducted and completed the crash investigation. See crash report for further information.

I made contact with Jeremy Bullard. Bullard advised while traveling north bound on S Beach Rd he began to slow down to make a right turn into a driveway. Bullard stated he activated his right turn signal prior to making the turn. Bullard stated a black SUV traveling behind him must not have seen him slowing down and struck his vehicle. After the collision, Bullard stated he and an unknown subject assisted the driver out of the vehicle. Bullard advised that due to the vehicle flipping on the driver's side, the driver was unable to exit properly and had to climb out from the front passenger side. Bullard advised he was the sole occupant in his vehicle and confirmed that the driver of the black SUV was the sole occupant. Bullard was able to physically point to the driver of the black SUV, who was identified as Eldrick T. Woods. I observed damage to the rear left fender and wheel of the trailer which estimated to be approximately \$5000.00 worth of damage. Bullard advised he did not sustain any injuries from the collision.

Deputy Brenovil and I made contact with Eldrick T. Woods. Deputy Brenovil provided the documentation pertaining to the crash and advised Woods that the crash investigation was complete. While Deputy Brenovil was speaking to Woods, I observed Woods to be sweating profusely. Woods was sitting in the back seat of a vehicle which had cool air flowing. After Deputy Brenovil finished his investigation, I informed Woods that I was with the Martin County Sheriff's Office Traffic/ DUI Unit. I advised Woods that Deputy Brenovil had conducted and completed the crash investigation which was a civil case and I was now conducting a criminal DUI Investigation to ensure he was able to operate the motor vehicle in a safe manner at the time of the crash. I inquired about the collision, to which Woods stated he was looking down at his cell phone and changing the radio station and did not notice the vehicle in front of him had slowed down. Woods stated he was coming from his house. Woods advised he did not sustain any injuries from the collision. While speaking to Woods, I observed him sweating profusely. Woods movement was lethargic and slow. Woods was extremely alert during the investigation. At this time, I was unable to look at Woods eyes due to him wearing sunglasses. I asked Woods if he was willing to perform a few field sobriety exercises to ensure he was able to operate the motor vehicle in a safe manner. Woods agreed to perform the field sobriety exercises. I instructed Woods to step out of the vehicle and walk to the front of my marked agency issued vehicle. While walking, I observed Woods limping and stumbling to the right. Woods appeared to have a leg injury and had a compression sock over his right knee. Once in front of my vehicle, I asked Woods if he had any medical conditions. Woods advised he's had seven back surgeries and over twenty operations on his leg. I asked Woods if he was able to perform tasks such as walking and lifting his leg, Woods advised he has a limp and his ankle seizes while walking. Due to Woods physical injuries, I instructed him to sit on the push bumper of the patrol vehicle for the remainder of the investigation. I instructed Woods to remove his sunglasses, Woods removed his sunglasses and ballcap. Once Woods removed his sunglasses, I observed his eyes to be bloodshot and glassy, I observed his pupils to be extremely dilated. I asked Woods if he consumed any type of alcoholic beverage to drink today to which he stated, "none". I asked Woods if he consumed any prescription medication to which he stated, "I take a few". Woods advised he takes medication for high blood pressure, cholesterol, ibuprofen, and Vicodin. Woods advised he took his prescription medication earlier in the morning. While speaking to Woods, I observed him to be extremely alert and talkative. Woods had hiccups during the entire investigation. I asked Woods if he consumed any illegal substances to which he stated no. While seated, I observed the following during the exercise:

Horizontal Gaze Nystagmus: The exercise was explained and demonstrated prior to him beginning the exercise. I instructed Woods to follow the tip of the pen with his eyes only without moving his head. Woods stated he understood and had no questions. I observed bloodshot and glassy eyes, no resting nystagmus, dilated, equal pupil size, lack of smooth pursuit in both eyes. There was no distinct and sustained nystagmus at maximum and the onset of nystagmus prior to 45 degrees. No vertical nystagmus. Woods continuously moved his head from side to side and had to be instructed several times to keep his head straight.

Finger to Nose: The exercise was explained and demonstrated prior to him beginning the exercise, Woods stated he understood and had no questions. Prior to being instructed to begin, woods closed his eyes and tilted his head back. When he was told to begin, Woods tilted his head back but did not close his eyes and had to be reminded to do so. Woods verified that he knew his left hand from his right hand by raising his left when asked "left" and his right hand when asked "right".

Left Hand: Hesitated for a few seconds before raising his hand. Raised his left hand and touched the tip of the nose with the print of the finger. Did not return hand back down to the side and had to be reminded.

Right Hand: Raised his right hand and touched the tip of the nose with the print of the finger. Eyelid twitching slightly.

Left Hand: Raised his left hand and touched the tip of the nose with the tip of the finger. Did not return hand back to the side immediately.

Right Hand: Raised his right hand and touched the tip of the nose with the print of the finger.

Right Hand: Raised his right hand, touched the tip of the nose with the print of the finger.

Left Hand: Raised his left hand, touched the tip of the nose with the print of the finger.

Palm Pat: The exercise was explained and demonstrated prior to him beginning the exercise, Woods stated he understood and had no questions. Woods was instructed to place his hands palm to palm with one hand up and one hand down. When instructed to begin, he was to turn the top hand over and count out loud "one" then turn the hand back over and count out loud "two", counting only when the hands make contact. He was instructed to speed up during the exercise and continue until he was told to stop. I instructed Woods to begin, he counted out loud "one", "two" but did not make contact with his hands between each count. Woods did not increase in speed and had to be reminded to do so.

Hand Coordination: The exercise was explained and demonstrated twice prior to him beginning the exercise, Woods stated he understood and had no questions. I explained the instruction to Woods, he was advised to place his left fist at the center of his chest and his right fist against his left. When told to begin he was to perform four tasks. First task was to count out loud from one to four while moving his fists in a step like fashion forward. Second task was to memorize the position of the fists after counting to four, clap hands three times and return fists to the memorized position. Third task was to move fists in a step like fashion in a reverse order, counting out loud from five to eight and returning left fist to the center of the chest. Fourth task was to open hand with palms down and place them in the lap. Woods did not remain in the starting position as instructed and demonstrated. While explaining and demonstrating the exercise, Woods began the exercise prior to my instructions. Woods was reminded to remain in the starting position until told otherwise. I instructed Woods to begin, on Task 1, Woods moved his fists in a step like fashion three times. Woods did not count his steps correctly but counted to four. Woods performed Task 2 correctly. On Task 3, Woods moved his fists in a step like fashion in reverse order counting out loud five, six, seven. Woods moved his fists three times instead of four times. Woods paused with his fists hovering in front of his chest, he did not touch his fist to the center of his chest as instructed and demonstrated. After a few seconds, Woods brought his fist to the center of his chest and counted eight. Woods performed Task 4 correctly.

Based on my observations of Woods, how he performed the exercises and based on my training, knowledge, and experience, I believed that Woods normal faculties were impaired, and he was unable to safely operate the motor vehicle. At approximately 1512 hours, I advised Woods that he was under arrest for Driving Under the Influence with Property Damage in violation of Florida State

Statue 316.193(3)(C)1.

During a search, Deputy C. Thomas located two white pills inside Woods left side pant pocket. A search of the pill through its identifying marks (M367) revealed to be Hydrocodone. The pills were collected and submitted into evidence.

Woods was transported to the Martin County Jail without incident. Once at the jail, I began the twenty-minute observation. Once inside the DUI Room and after the twenty-minute observation, Woods was requested to submit to a lawful test of his breath for the purpose of determining its alcohol content. Woods agreed to provide the breath test. The results are as follows:

Sample #1: 0.000g/210L

Sample #2: 0.000g/210L

Woods was requested to submit to a lawful test of his urine for the purpose of determining the presence of chemical or controlled substances. Woods refused to provide the urine test. I read the Florida Implied Consent for the Urine Test from an agency issued form. Woods advised he understood but still refused to provide the urine test. I advised Woods that if he changed his mind during my time at the jail to let the booking deputies know and the urine test would be administered and the Implied Consent would not apply. Woods refusal time was documented at 1633 hours.

Due to Woods refusing to provide the urine test, he was charged with Refusal to Submit to BAL Test in violation of Florida State Statue 316.1939(1)(E).

Due to medical staff requesting a medical clearance from the hospital due to Woods being involved in a traffic crash, he was transported to Cleveland Clinic ER South. Woods refused all medical treatment. After being medically discharged, Woods was transported back to the Martin County Jail.

After being turned over to the booking deputies at the jail, Woods was issued the following citations:

Florida State Statue: 316.193(3)(C)1, Driving Under the Influence with Property Damage. Citation #ALG5J1E.

Florida State Statue: 316.1939(1)(E), Refusal to Submit to BAL Test. Citation #AN87BTE.

All encounters with Woods were captured on my agency's issued body, car, and DUI Room camera and were submitted to Evidence. Com.

Woods vehicle was towed by All Hooked Up.
